RICKLEFS is a curated professor of biology at the University of Missouri St. Louis, where he has been a faculty member since 1995. His teaching in Missouri, and previously at the University of Pennsylvania, includes courses in introductory and advanced ecology, biogeography, evolution and biological statistics. Bob's research covered a wide range of environmental and evolutionary biology issues, from the adaptive significance of bird life to island biogeography and community relations between birds, herbivores and forest trees. In particular, he defended the importance of recognizing the impact of large-scale processes on local environmental assemblies of species. Bob has published in numerous journals including Science, Nature, PNAS, Evolution, Ecology, Ecology Letters, and Naturalist. His contribution was recognized by honorary doctors of the University of Catalonia (Belgium), Aarhus University (Denmark) and the University of Burgundy (France). He is a member of the American Academy of Arts and Sciences and the National Academy of Sciences of the United States. Bob published the first edition of Nature Economics in 1976 and joined Rick Relyea with the seventh edition. Rick Relyea is director of the Darrin Institute of Freshwater at the Rensselaer Polytechnic Institute. He is also director of the Jefferson Project at Lake George, an innovative partnership between Rensselaer, IBM, and FUND for Lake George. For the project, Relyea leads a team of scientists, engineers, computer scientists and artists who use the latest scientific and technological technologies to understand, predict and provide a sustainable ecosystem for nearby Lake George. She was at the University of Pittsburgh from 1999 to 2014. In 2005 he was named Distinguished Research Chancellor, and in 2014 he received the Tina and David Bellet Award for Excellence in Teaching. From 2007 to 2014, Relia served as director of the university's field station, the Pimatun Ecology Laboratory, where he oversaw a diverse set of environmental field courses and assisted researchers from around the world. Rick taught thousands of students introductory ecology, behavioral ecology and evolution. His research is recognized worldwide and has been published in the journal Ecology, Ecology Letters, American Naturalist, PNAS and other leading environmental journals. The study covers a wide range of environmental and evolutionary topics, including animal behavior, sexual selection, ecotoxicology, disease ecology, phenotypic plasticity, community ecology, ecosystem ecology and landscape ecology. Relyea's research is now focused on aquatic habitats and the diversity of species found in these ecosystems. Christoph Richter is a lecturer in biology at the University of Toronto-Mississauga, where he has been working in the faculty since 2011. He began his teaching career in 2002 at King's University, where he was recognized for his excellence in teaching. Since then, he has taught undergraduate courses on many topics, including animal behavior, vertebrate biology, marine mammology, biodiversity, introductory ecology and statistics. It aims to attract students by making the content of the course meaningful and demonstrating the dynamic nature of research. His teachings led him from the Arctic to the Gulf of Maine M.Sc. His research focused on the impact of human activities, such as fishing, whale watching and oil exploration, on the behavior of cetaceans. He studied humpback whales, porpoises and sperm whales off Newfoundland and New zealand and in Fundy and the Gulf of Mexico.Christophe is currently researching focused on improving pedagogical performance. He studies how opinion and knowledge of evolutionary concepts change throughout the undergraduate program and what factors influence student success in their studies.
